General Information

The Northern Alberta Institute of Technology (NAIT) is a multi-campus institution offering a wide range of programming in Business, Engineering, Technologies, Health and Medical Sciences, Industrial Technologies, Applied Arts and Hospitality and Personal Services. Campuses are located in Edmonton (Metro) and St. Albert.

As of July 2009, the Fairview, Peace River, High Level and Grande Prairie campuses are no longer part of NAIT. Unless specified otherwise the legends listed below were in effect for these campuses as well.

Accreditation

NAIT is a fully accredited post secondary institute operating under the auspices of the Post-Secondary Learning Act, Government of Alberta, Advanced Education.

Student Evaluation

Student achievement is evaluated and recorded using one of the systems outlined below.

For programs using a numeric system of evaluation, the weighted average for each instructional term is calculated by multiplying course hours by course mark and dividing the sum of these by the total attempted hours of instruction.

All Campuses Prior to July 1, 2004 (Exception: Fairview College between July 2001 and June 2004 – see below)

Marks of 49% or lower were recorded as failures on all programs with the following exceptions where marks of 59% or lower were considered failures: Combined Laboratory and X-Ray Technician Court Reporting Cytotechnology Emergency Medical Technology – Paramedic Food Service and Nutrition Management Medical Laboratory Technology

Competency Based System

This system of evaluation is applicable to those programs that have developed and implemented a unitized competency-based curriculum.

- H Honours to indicate superior achievement
- P Pass to indicate fully satisfactory performance
- IN Incomplete to indicate that the student has not met competency standards or withdrew from the course after completing half or more of the course hours
