***Important to Note:

Copies of course outlines, in English, from all courses completed to obtain AHT/VT diploma or copies of course outlines from all courses being submitted may assist in the accurate evaluation of transcripts but are NOT required to be submitted.

Separate application must be made for AHT Clinical Skills Evaluation. Successful completion of all 3 previous assessment stages, Educational/credential assessment, English Proficiency Exam eg. TOEFL and Exam in General Veterinary Knowledge, will qualify you to apply to Clinical Skills Evaluation.

Successful completion of all 4 stages of assessment results in a certificate of completion that may be submitted to your provincial registration body for Animal Health Technologists or Veterinary Technicians. This certificate may qualify you to apply to write the Veterinary Technician's National Exam.
