



## Education Abroad Award Application

This award is available to any NAIT student enrolled in a full-time credit program. An applicant must be approved for a semester long international exchange (min 10 weeks duration) for which they will receive credit. The exchange must take place by the January following the current academic year. The Study Abroad Award is allocated based on defined criteria, including a minimum GPA of 2.7, relevancy of the activity to the program of study or career aspirations, potential for learning and growth, and financial need. Recipients must complete pre-departure and re-entry training before and after their international experience, and must be willing to share their experience with the NAIT community through photos, blogs, testimonials, info sessions, etc. Recipients will also be required to complete a report upon their return.

The number of awards disbursed will vary depending on the number of qualified applicants and availability of funds. The award amount is \$2,000.

- If a student withdraws from the abroad opportunity for which the funding was sought, the funding must be returned to NAIT.
